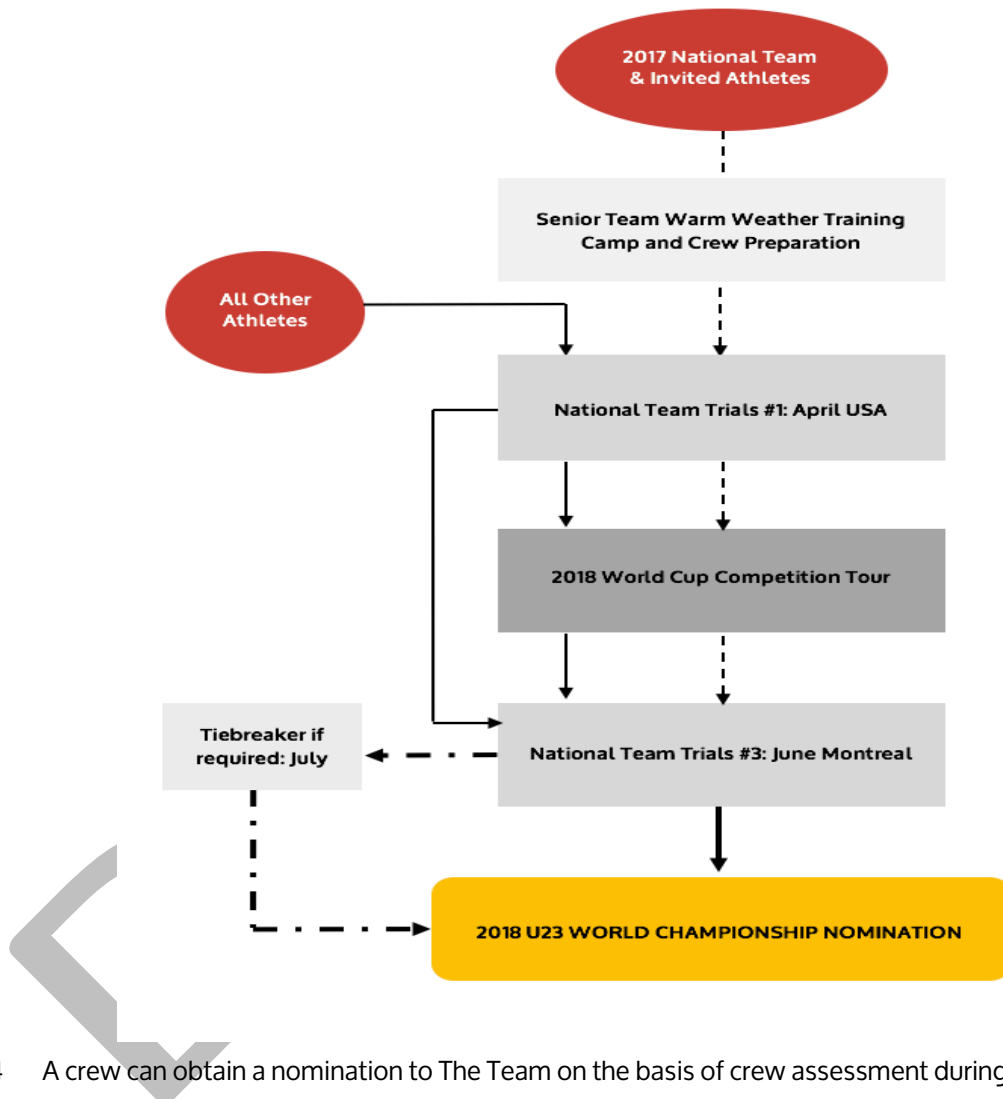
1. Performance Objectives

The following 2018 U23 World Championships Team Selection Criteria are guided by CKC's performance objectives where a crew demonstrates the ability/potential to make a Top 8 at the U23 World Championships and be progressing toward the podium at Senior World Championships and Olympic Games.

2. Selection Overview

- 2.1 Crews who are vying for a nomination to the U23 World Championship Team (The Team) will do so as part of the Senior World Championship Selection process.
- 2.2 The 2018 competitions that will be used in the selection of the Team are:
 - 2.3.1 National Team Trials #1, April 20-22, Gainesville, Georgia
 - 2.3.2 World Cup #1, May 18-20, Szeged, Hungary
 - 2.3.3 World Cup #2, May 25-27, Duisburg, Germany
 - 2.3.4 National Team Trials #3, June 22-24, Montreal, Quebec

2.3 To assist crews and coaches, an overview of the selection process is provided below. This chart is an outline of the various paths toward nomination to the Team. The chart is only a guideline and one should review thoroughly review the criteria that follow



2.4 A crew can obtain a nomination to The Team on the basis of crew assessment during the Senior World Championships selection process.

2.4.1 See 2018 Senior World Championships Selection Criteria Supplement for details.

2.5 It is not a requirement for Canoe Kayak Canada to enter crews in all events at all competitions

2.10 Final selection of the Team, by the Selection Panel, will occur on or before July 15, 2018.

2.10 All nominations must be approved by the HPC

2.8 All entries at the 2018 U23 World Championships must be approved by the HC.

2.9 The number of crews selected to the Team is dependent on the quality of the performance. Factors that will be considered when assessing the quality of performance includes but is not limited to:

- % GMT (U23) - An athlete/crew's performance against a Gold Medal Time (see Appendix A)
- % AFT (U23) - An athlete/crew's performance against an A-Final Time (see Appendix A)
- % Winner
- Known Performance (e.g. results against known international competitors in the race)
- Performance history (e.g. international results)
- Ranking Lists (See Ranking List points chart in Appendix B)
- Ranking Progression (Improvement or decline in National Rank)

These factors are in no particular order and one or more may be used to either support or dismiss a selection.

2.10 Additional crews who are not part of the initial Discipline Pool following NTT1 may be considered for nomination based on Discipline Pool Assessment at the conclusion of NTT3 in the Olympic singles and tandem events and / or performance on the relevant combined ranking list as follows:

- Men's Kayak 1000/500
- Men's Kayak 500/200
- Women's Kayak 500/200
- Women's Canoe 500/200
- Men's Canoe 1000/500

APPENDIX A

Performance Times

Any performance times to be compared against the A-Final Time (AFT) will be rounded to the 10th of a second
