

2022 SPRINT NATIONAL TEAM TRIALS 2: ATHLETE REGISTRATION

What to do to prepare

Athlete will be required to register themselves in advance of their coaches submitting the entries. In this process, your basic information will be required, along with signing of waivers and consent forms. Finally, there will be the ability to pay by credit card through the system if that is the option selected.

Athletes who are minors should ensure their parents are able to complete these steps register them in the event (age of majority is needed for signing the waivers).

Documents you should have ready to upload: Copy of your passport Copy of your COVID vaccinations Optional – headshot for accreditation purposes

Landing page & Dashboard

To login to the registration system, you will be logging into the "<u>Canoe Kayak Canada Programs</u>" page. Please choose your language and create an account if you do not have one already. Please note, parents can create accounts and register their children and this same account can be used for their clubs (same for athlete accounts, they will be the same account that can be used for their clubs).





Once you have successfully logged in you will get to the following page, where the default view is the "Dashboard" view. To note, there may be options depending on what is available at the time of registration.


